The maker(s) and endorsers hereof jointly and severally waive presentment for payment, notice of non-payment and right of protest and further agree to any extension of time of payment and partial payments before, at or after maturity, and further agree that if the principal is not paid when due and suit is brought or foreclosure initiated, to pay all costs of collection, including reasonable attorney's fees and expenses, court costs and all fees and costs of the Public Trustee (where applicable).

If applicable herein, maker(s) swear, affirm and represent that the real property described herein, is free and clear of liens or encumbrances, subject to those described above.

THIS PROMISSORY NOTE shall become null and void in the event Defendant appears in the court for which the bail bond was posted, at all times required by the court, the Defendant and Indemnitors fulfill all conditions of the bail bond for which this note was drafted and Surety is fully and finally discharged and exonerated from all liability upon said bail bond; otherwise this note shall remain in full force and effect.
